

# **Get Involved and Share Your Learning Story**











Wolverhampton City Learning Region celebrates and promotes how learning can improve and transform lives. People often don't realise that learning throughout life (lifelong learning) has many benefits and these are wide-ranging.

We are gathering learning stories from people who live, work or study in the City of Wolverhampton about how learning has made a difference to their lives. We would love to hear from you! By sharing your story you will help inspire others to get involved. We will also find out about the many ways in which learning is transforming lives in the City of Wolverhampton.

## Share your learning story and celebrate learning in the City of Wolverhampton

We learn for many reasons and in so many different ways and places – for example through friends, family, activities, community groups, formal education, at work etc.

### Please tell us about what you have been learning and the difference this has made to your life?

- Your learning story can be from any stage of your life.
- Your learning story might be about a learning experience that made a difference to your life, about
  one thing that you learnt that has made a positive change in your life, it might tell the story about
  your learning journey showing how what you learnt has impacted on your life or the life of your family
  or friends.

## **Creating your learning story**

You can share your learning story with us in a way that best suits you.

- You can write it or you can tell it in a different way such as: create a short video clip, create a short audio recording, set it to music as a song or rap song, write a poem, create a picture or take a photograph etc. All learning stories are welcome! Your learning story will need to communicate what you learnt and the difference it made to your life.
- If you are creating a short video clip or audio recording or song, we suggest the duration is no longer than approximately 2 minutes.
- Please read the 'Privacy Notice' below this explains how we collect and handle your personal data.

## To help you think about creating your learning story, here are some questions you can use:

- What have you learnt recently or in the past that has made a difference to your life?
- Where did the learning take place?
- How old were you?
- How did this learning come about? What was the reason for the learning?
- Was it an easy thing to learn or was it hard and challenging?
- Did you learn with other people?
- How did you feel about what you learnt?
- Did it lead to a small or large change in your life?
- Have you shared that learning with anyone else? Did it or they make a difference to them?

## How to share your learning story – what to do next

- Please ensure you have read the 'Privacy Notice' about how we collect and handle your personal data.
- Please read and complete the WCLR Learning Story 'Consent Form'. Ensure you fill in all the details.

- A photo of yourself to accompany your story. If you do not want to share a photo of yourself, please let us know.
- If you are under the age of 18 please ensure you have consent of a parent /guardian to take part.

### Who we are

Wolverhampton City Learning Region celebrates and promotes how lifelong learning can improve and transform lives. We are collecting Learning Stories from people who live, work or study in the City of Wolverhampton to share to help publicly promote how learning can make a difference to people's lives and benefits of learning throughout life.

The Wolverhampton City Learning Region core partner organisations are: University of Wolverhampton, City of Wolverhampton Council, Adult Education Wolverhampton, City of Wolverhampton College, Wolverhampton Learning Platform and Wolverhampton Learning Communities. The City of Wolverhampton is a member city of the UNESCO Global Network of Learning Cities.

The Wolverhampton City Learning Region core partner organisations are 'Joint Controllers' as defined by the Data Protection Act 2018 and are responsible for, and control the processing of your Personal Data. We are committed to protecting your privacy. This notice explains how the University of Wolverhampton collects and processes your Personal Data on behalf of The Wolverhampton City Learning Region.

### How We Use Your Data

The University of Wolverhampton will collect and process your personal data on behalf of Wolverhampton City Learning Region core partners. We will review the Learning Story you submit and the related information to decide if it should be shared publically. The Wolverhampton City Learning Region core partners will be involved in the process of reviewing your Learning Story for sharing publicly as we review all submissions carefully. The University of Wolverhampton may contact you to discuss your Learning Story in further detail.

Your submitted Learning Story (including any photographs, video footage/stills, audio recordings and information you provide as part of your Learning Story) may be shared on the Wolverhampton City Learning region webpage <a href="https://www.wlv.ac.uk/learningregions">www.wlv.ac.uk/learningregions</a> under the love learning section <a href="https://www.wlv.ac.uk/lovelearning">www.wlv.ac.uk/lovelearning</a> and may be featured on the websites of any of the Wolverhampton City Learning Region core partners or any related UNESCO Global Network of Learning Cities websites. Your Learning Story may also be shared via social media and with the local and national press as part of public relations exercises and press releases.

### **Information We Collect**

The information that we process about you will be provided by you. This will typically be via our designated Wolverhampton City Learning Region email address or website or collected from any information you post to us if you do not have access to use of a computer.

Information provided by you will include details such as your full name, and contact details, such as address, email address and telephone number any information relating to your Learning Story (video footage) and a photo if you choose to submit one.

The lawful basis we rely on for processing this information is your explicit consent will be obtained before you submit your Learning story via the consent form, which will include your consent to share your information with the partners and publish your story online. You may withdraw your consent at any time. To do so please contact dataprotection@wlv.ac.uk

### Who We Share Your Personal Data With

We will only share the minimum amount of personal data with any of the above and will always do so in accordance with the law.

### Retention

Your data (Your submitted Learning Story (including any photographs, video footage/stills, audio recordings and information you provide) is retained for up to 3 years for the purpose of Wolverhampton City Learning Region reviewing your learning story or publicly sharing it to celebrate and promote how lifelong learning can improve and transform lives.

If your Learning Story was shared publicly it may remain on the Wolverhampton City Learning region webpage <a href="www.wlv.ac.uk/learningregions">www.wlv.ac.uk/learningregions</a> under the love learning section <a href="www.wlv.ac.uk/lovelearning">www.wlv.ac.uk/lovelearning</a> or other related websites unless you request for it to be removed. Whilst we will restrict sharing of all learning stories to the social media channels we intend to use, we cannot guarantee that anything once on a social media channel is not then shared by individuals further on the internet and it may not be possible to trace such data to delete it.

**Please note:** whilst we will restrict sharing of all Learning Stories to the social media channels we intend to use, we cannot guarantee that anything once on a social media channel is not then shared by individuals further on the internet and may not be able to trace such data to rectify or delete it.

### **Your Rights**

As an individual, you have a number of rights available to you. In this instance, the following rights are available to you:

- Right to request a copy of your information. You can request a copy of all the information which we
  have about you (this is known as a subject access request).
- Right to correct mistakes in your information. You can ask us to correct any mistakes in the information
  which we have about you.
- Right to have your information deleted. If you no longer want us to hold any information about you, there are a number of circumstances where you can ask us to delete your information.
- Right to ask us to restrict the processing of your personal data in certain circumstances. This means
  every time we process your personal data we will consider any requests you have made for us not to
  proceed.

- Right to object to the processing of your personal data and the right to withdraw your consent.
- Right to ask us to transfer your data to another organisation, also known as the Right to Portability.
